Metric	Where we are today (data as of 9/12/20)
<b>Community Spread</b>	
Sustained decrease in community spread	Increasing trend
Low transmission rate ( $R_t$ )	$R_t = 0.81$
<b>Testing Capacity</b>	
Low positivity rate	2.1%
<b>Health Care System Capacity</b>	
Sufficient health care capacity without surge	79.7%
<b>Contact Tracing</b>	
Make first contact attempt for new positive cases within 1 day of notification	99.6%
Make first contact attempt for close contacts of new positive cases within 2 days of identification	94.5%
Percent of positive cases from quarantined contacts	3.4%


