### **ASYMPTOMATIC TESTING**



For the remainder of the 2021-22 school year, schools will continue with symptomatic testing and random asymptomatic testing at 20%, the ability to test up to 30% of their student populations when case rates are high.

For the remainder of the 2021-22 school year, the District will distribute rapid antigen tests to all DCPS and public charter schools to be used before returning from any break that is at least a full school week (e.g., February Break and Spring Break).

Beginning this week, the District will distribute one rapid antigen test kit per week to all registered pre-K and kindergarten students in DCPS and public charter schools. Tests will be available by Friday of each week and be administered before coming back to school on Monday.

This program will continue through at least the latest surge in cases.

# DCPS staff and public charter school staff will also receive one rapid antigen test kit per week.

### Planning is underway to launch a new Test to Stay model in schools, based on CDC guidelines.

The Test to Stay program will allow students who are identified as close contacts and not fully vaccinated the ability to take a series of rapid COVID-19 tests during their isolation period. If these tests return negative, the student can remain in school for in-person learning.

Test to Stay will first launch in Early Childhood Education and Elementary Schools with a smaller pilot for select Middle and High Schools.


