

On Wednesday, June 19, Mayor Bowser hosted a press conference to address litter and rat abatement throughout the District. Mayor Bowser championed her #BacktoBasics campaign, which focuses on the collaboration between DC Government and the community to work hand and hand in keeping DC moving forward. 


During the walk, Mayor Bowser engaged with residents in the community.






Litter at Harriet Tubman Elementary School and along Park Road NW is an ongoing concern for community members
