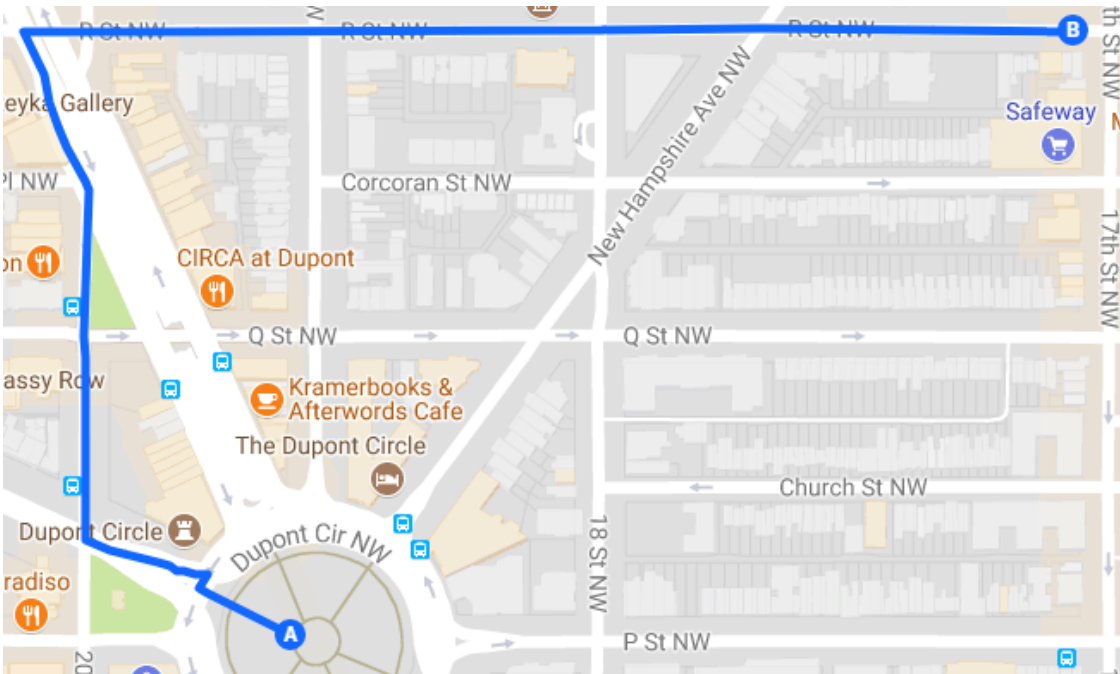


Ward 2: Dupont Circle Muriel Bowser, Mayor
